Release, Waiver of Liability and Indemnification Agreement

I, _____, have voluntarily agreed to participate in the training program that is being presented by Level Up Adventures LLC (hereafter the "Training Program").

I am aware that there are significant risks involved in all aspects of physical training, and participants will engage in physical training exercises that may include, but not limited to, close quarters combat combative training drills, ground fighting, application of pressure points, achieving physical control over others, throws, falls, jumping, running, balancing, falling, rolling, climbing, lifting, entering into bondage and/or restraints, and scenario simulations. The training may also require environmental exploration including wilderness and urban activities that require participants to actively engage in their surroundings. I additionally understand that I may experience mental and emotional stress as a result of my participation in the Training Program. I am aware that any of the aforementioned risks may result in serious injury or death.

I willingly assume full responsibility for the risks that I am exposing myself to and accept full responsibility for any injury or death that may result from participating in any event, activity, or Training Program, including activities in preparation of and/or subsequent and related to the training provided by Level Up Adventures LLC. I, the undersigned, certify that I have no condition, mental, emotional, and/or physical, that would prevent me from participation and/or endanger anyone associated in the Training Program. In consideration of the above mentioned risks and hazards and in consideration of the fact that I am willingly and voluntarily participating in the activities and Training Program made available by Level Up Adventures LLC, I, the undersigned, here by release Level Up Adventures LLC, their principals, agents, employees, and volunteers from any and all liability, claims, demands, actions or rights of action, which are related to, arise out of, or are in any way related to my participation in the Training Program, including any allegedly attributed to the negligent acts or omissions of the above mentioned parties.

I expressly agree that this Release, Waiver of Liability, and Indemnification Agreement is intended to be as broad as permitted by applicable laws and that if any portion thereof is held invalid, the balance shall, notwithstanding, continue in full force and effect. The present contains the entire agreement between the parties hereto and the terms of this Agreement are contractual and not a mere recital. Furthermore, this agreement shall be binding upon me, my successors, representatives, heirs, executors, assigns, or transferees.

The participant recognizes that there is risk involved in the types of activities offered by Level Up Adventures LLC. Therefore, the participant accepts financial responsibility for any injury that the participant may cause either to him/herself or to any other participant due to his/her negligence. Should the above mentioned parties, or anyone acting on their behalf, be required to incur any attorney's fees and costs to enforce this agreement, I agree to reimburse them for such fees and costs. I further agree to indemnify and hold harmless Level Up LLC, their principals, agents, employees, and volunteers from liability for the injury or death of any person(s) and damage to property that may result from my negligent or intentional act or omission while participating in activities offered by Level Up Adventures LLC.

I certify that I have read and understood the foregoing assumption of risk, and release of liability and I understand that by signing it obligates me to indemnify the parties named for any liability for any injury or death of any person and damage to property caused by my negligent or intentional act or omission. I understand that by signing this form I am waiving valuable legal rights. This is a legally binding agreement, which I have read and understood.
